**PLEASE READ THESE GAME TERMS AND CONDITIONS ("AGREEMENT") CAREFULLY BEFORE PLAYING WANDERERS. BY ACCESSING OR PLAYING THE GAME, YOU ("YOU," "YOUR," OR "USER") AGREE TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE, DO NOT ACCESS OR PLAY THE GAME.**

Wanderverse Inc. d/b/a WanderLabs and its Affiliates ("Company," "we," "us," or "our") owns and operates the video game Wanderers (the "Game"), accessible via <https://www.wanderers.ai> (the "Site"). This Agreement governs your access to and use of the Game and any related services, features, or content made available through the Game (the "Services").

This Agreement applies solely to the Game and its in-game Services. It does not govern any digital collectible or other product offered separately by WanderLabs, which are subject to their own terms.

### 1. ENTIRE AGREEMENT

This Agreement and our Privacy Policy comprise the entire agreement between you and WanderLabs with respect to the Game, and supersede any prior agreements between the parties on this subject. By using the Game, you confirm that you are authorized to do so and will comply with this Agreement and all applicable laws, rules, and regulations.

### 2. DESCRIPTION OF THE GAME

Wanderers is an evolving science fiction interactive gaming experience, playable via web browser at <https://www.wanderers.ai>. WanderLabs' goal is to build a growing community of players within a dynamic narrative universe. The Game may include gameplay features, social features, leaderboards, optional in-game purchases, randomized card packs, rewarded advertising, and other entertainment experiences.

The Game and all Services are provided to you "as is." WanderLabs makes no promise of continuous availability or any particular feature set. The Game does not incorporate, reference, or make use of any non-fungible tokens (NFTs) or blockchain-based assets.

### 3. ELIGIBILITY

The Game is intended for users 18 years of age or older. By accessing or playing the Game, you represent and warrant that you:

- are at least 18 years old;
- have read, understood, and agree to be bound by this Agreement;
- are not located in, or a resident of, any country subject to a U.S. government embargo or otherwise designated as a restricted jurisdiction; and

- are not listed on any U.S. government list of prohibited or restricted parties.

If you are a parent or guardian and become aware that a minor under your care has accessed the Game in violation of this Agreement, please contact us immediately at [legal@wanderers.ai](mailto:legal@wanderers.ai) and we will take steps to remove the relevant information from our systems.

If you do not meet these requirements, you must immediately stop using the Game and Services.

#### **4. ACCOUNT REGISTRATION**

To access certain features of the Game, you may be required to register for an account. You agree to:

- maintain the security of your account credentials and not share them with any third party;
- notify us immediately of any unauthorized access to or use of your account; and
- accept responsibility for all activity that occurs under your account.

WanderLabs reserves the right to terminate or suspend any account that violates this Agreement or at our sole discretion for any other reason.

#### **5. IN-GAME PURCHASES**

The Game offers optional in-game purchases, including virtual currency, cosmetic items, gameplay enhancements, randomized card packs, or other digital content ("Virtual Items"). All purchases are processed through our authorized web-based payment provider on the Site.

By making an in-game purchase, you agree to the following:

- All purchases are final. Virtual Items are non-refundable except where required by applicable law.
- Virtual Items have no real-world monetary value and may not be redeemed for cash or transferred outside the Game.
- WanderLabs reserves the right to modify, remove, or discontinue any Virtual Items at any time without liability to you.
- You are responsible for all charges incurred under your account, including purchases made by others with access to your account.

WanderLabs is not responsible for unauthorized purchases made through your account. Please safeguard your login credentials and payment information at all times.

#### **6. RANDOMIZED CARD PACKS — LOOTBOX DISCLOSURE**

**IMPORTANT NOTICE: THIS GAME CONTAINS RANDOMIZED CARD PACKS ("LOOTBOXES") WHICH AWARD ITEMS BASED ON CHANCE. PLEASE READ THIS SECTION CAREFULLY BEFORE MAKING A PURCHASE.**

The Game includes purchasable randomized card packs that contain randomly selected in-game items. The specific contents of each pack are determined at the time of opening and are not guaranteed in advance.

WanderLabs reserves the right to update drop rates at any time. Any changes will be reflected in this Agreement and posted at wanderers.ai prior to taking effect. Purchasing a randomized card pack after any such update constitutes your acceptance of the revised rates.

Players are encouraged to review drop rates before making any purchase. Randomized card packs are intended for entertainment purposes only and do not guarantee any specific item or outcome.

**7. GEOGRAPHIC RESTRICTIONS — RANDOMIZED CARD PACKS**

Due to applicable laws and regulations in certain jurisdictions governing randomized in-game purchases, the purchase of randomized card packs is **not available** to users located in or residents of the following countries:

You agree to indemnify, defend, and hold harmless WanderLabs and its subsidiaries, Affiliates, officers, directors, agents, and employees from and against any and all claims, liabilities, damages, losses, and expenses (including reasonable attorneys' fees) arising out of or in any way connected with: (a) your access to or use of the Game; (b) your violation of this Agreement; (c) your violation of any applicable law or the rights of any third party; or (d) your User Content.

WanderLabs may suspend or terminate your access to the Game at any time, with or without notice, for any reason including a breach of this Agreement. #### **18. GOVERNING LAW AND JURISDICTION**

This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware, without regard to its conflict of law provisions. You and WanderLabs consent to the exclusive jurisdiction of

the state and federal courts located in New Castle County, Delaware for the resolution of any disputes. Each party waives, to the fullest extent permitted by law, any objection to venue in such courts.

## **19. DISPUTE RESOLUTION**

**ALL DISPUTES MUST BE BROUGHT IN YOUR INDIVIDUAL CAPACITY ONLY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS, COLLECTIVE, OR REPRESENTATIVE PROCEEDING.**
